TRADE SITE RULES AND CONDITIONS

**On payment of a site, site holders agree to abide by the following conditions.
All Decisions of the Mt Larcom District Show Society Committee are final and binding.**

- Stallholders must satisfy all COVID-19 requirements that are applicable in the lead up to and on the days of the show. Stallholders must have their own COVID safe plan for their stall and provide a copy of their Compliance Plan to the Society prior to the show. COVID safe plans must follow the key COVID safe principles relating to COVID screening, physical distancing, sanitiser, signage, entry/exit points and foot markers to operate their stall in a Covid safe manner.**

Sign into the showgrounds each day using the QR codes provided and answer the COVID questions.

Ensure that their stall is set up in a manner that prevents or manages pedestrian queueing and ensures no cross over of pedestrian walkways.

Provide their own sanitiser and signage and other consumable items relating to their COVID safe plan.

Promote contactless payment methods.

Not offer self-service to food or beverages or have tables and chairs set up near their stall.

2. The committee has the final right to accept or reject any application, all requests for refunds will be at the discretion of the committee and considered on a case by case situation.
Display of approved advertising signs of any description is restricted to the area occupied by the site holder. The committee shall have the power to enter upon the site allotted and remove any article, sign, picture or printed matter which in the Societies opinion may be a cause of offence to the public?
Socially sensitive sites will not be accepted and there will be no exclusive trading rights agreements.
It is the responsibility of the Trades Site owner to be aware of banned goods at Qld Shows, a list can be supplied.
All stallholders must abide by the relevant legislation relating to their product, service or activity.
These food items are limited to the showmen – fairy floss, dagwood dogs, toffee apples, snow cones.
Sites are to be set up for business and vehicles of show grounds by 8am each Show day.
3. The committee will allocate sites, should a reposition of the site be requested, the committee have the right to make the final decision. Entry and Exit to the Showgrounds will be as directed by organisers.
4. Sites are not under cover. **Site holders must provide their own equipment (eg. Tents, table and electrical cords)**
No electrical cords are allowed across roadways and all electrical equipment and leads must be test and tagged by a licenced electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of Workplace Health and Safety Act 1989. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit.
5. A vehicle may be used as a stall, but along with all equipment it must fit into the space allocated unless by arrangement with the organiser, an extra charge of \$20 may apply for vehicles on site in some circumstances. Stall holder's vehicles not used as a stall must leave the grounds. There is allocated outside parking for stallholders.
6. The selling of raffle tickets is prohibited by any stallholder, other than affiliated Show Society members.
7. Site holders must dispose of their rubbish (not in Show Society bins). The Show is run by Volunteers please help us, by keeping your area clean and tidy.
8. Single use plastic bags are banned for use in Queensland and are not permitted to be used at the show.
9. Site holders are responsible for their own Public Liability Insurance. The Mt Larcom District Show Society will not be responsible for any costs of action bought against site holders. The organisers do not accept any liability for damage, loss, theft, or misuse of any goods brought to the showgrounds.
10. All dogs within the grounds must be restrained on a short leash.

Waiver:

1. I acknowledge that it is a condition of participating in this Event that I do so at my own risk. I accept all risks and release the Society from all claims, demands and proceedings arising out of or connected with my participation in the Event and indemnify them against all liability for any injury, loss or damage arising out of or connected with my participation in the Event. This release continues forever and binds all of my heirs, successors, executors, personal representatives and assigns.

2. I acknowledge that it is a condition of participating in the Event that the Society and any person or body directly or indirectly associated with the Event are absolved from all liability arising for injury, death or damage to myself or my property howsoever caused arising out of my participation in the Event whatsoever whether due to any negligent act, breach of duty, default and/or omission on the part of the Society and any person or body directly or indirectly associated with the Event, or otherwise.

3. I acknowledge that the Society relies on the information provided by me and state that all such information is accurate and complete.
